Dear Ms. Arnold-Williams:

We are pleased to inform you that Washington's 10th State Children's Health Insurance Program (SCHIP) State plan amendment (SPA) submitted April 3, 2008, with additional information submitted on August 26, 2008, October 14, 2008, and October 28, 2008, has been approved.

This SPA permits Washington to institute a pilot Application Agent program to assist families applying for SCHIP and other child health programs in the State. Washington will receive enhanced Federal match on a \$75 fee paid to the application agent in 32 Local Health Jurisdictions and 6 Community-Based Organizations for each application that results in new coverage. Washington will also receive an enhanced Federal match to finance a media campaign for its *Apple Health for Kids* program. The State will claim these expenditures under its 10 percent administrative cap.

The State will be required to track and report the number of successful Medicaid and SCHIP enrollments as a result of this initiative in the Medicaid and SCHIP Budget and Expenditure System. The State will also be required to report on these efforts in their State Annual Reports.

This amendment has retroactive effective dates of July 1, 2007, for the media campaign and October 1, 2008, for the Application Agent program.


